

# 2018 CHALLENGE BATHURST

## EVENT DATES 15 TO 18 NOVEMBER

### MERCHANDISERS & TRADERS PROPOSAL

#### Background and General Information

The third annual Challenge Bathurst (Event) will be held at Mount Panorama, Bathurst over the period 15 to 18 November 2018. The Event will incorporate a two-day 'super-sprint' activity and a two-day 'regularity' activity. The first ever-motor race was held at Mount Panorama in 1938 and the circuit is only able, by Act of Parliament, to be fully closed five times a year. Challenge Bathurst joins the Bathurst 12 Hour, Bathurst 6 Hour and Bathurst 1000 as the fourth event on the calendar. Unlike the other three annual events held at the Circuit, CB will not comprise any 'racing' per se. Rather, the Event provides an opportunity for a various levels of drivers to drive their performance race car in the 'sprint' component or in the 'regularity' component.

Merchandisers and Traders will have up to **200** 'super-sprint' competitors to target on 15/16 November and up to **275** 'regularity' competitors to target on 17/18 November 2018. There is no charge for spectators to attend the Event however very few are expected. Over **420** competitors attended the 2017 Event and we expect this number to increase in 2018.

Challenge Bathurst is promoted and organized by Yeehah Events (Yeehah) and Sports Down Under in conjunction with Bathurst Regional Council. More information can be found at [www.challengebathurst.com](http://www.challengebathurst.com)

#### Sites & Fees

Merchandise and traders will be located in the Inner Paddock (behind the Pit Garages). Fees correlate to the footprint of the tenant, with details as follows:

Small site (up to 6x3m)	\$500 plus GST
Medium site (up to 8x5m)	\$1,000 plus GST
Large site (up to 12x6m)	\$1,500 plus GST
Extra large site (Pantech+)	\$2,000 plus GST

- ✓ 100% payable (refundable if withdrawn NLT 14 days pre Event) when booking accepted
- ✓ Please note that bookings are taken on a 'first in, first served basis' and subject to available space
- ✓ No food or beverage of any kind is permitted to be sold by merchandisers/traders

#### Set Up Costs & Official Suppliers

At set-up costs are borne by the tenant. This includes such things as marquee, electrical reticulation, plumbing, tables and chairs etc. Once we have confirmed your booking you will be issued with an Official Suppliers List for the Event, which will contain contacts for various suppliers. If you choose to erect your own structure, please be aware that no peg and pole structures are allowed at the Event. Accreditation will not be provided to a competitor of an Official Supplier. Additionally, access to the Event may be denied. Please note that mains power is available and can be used by the tenant at no cost.

#### Set Up Times

Set-up must be completed by COB Wednesday pre Event. If set-up is not completed by Wednesday evening, it must be completed outside of trading hours (after 6pm and before 8am). Vehicles (other than display vehicles) will not be permitted to park in the Paddock, unless they are contained within the site dimension paid for. Vehicles not authorised

to park in the Paddock will be towed at the owner's expense. Car parking will be available near the Outer Paddock for Tenant's vehicles. All rubbish as a result of set-up or trading must be removed before the next day's trading commences. This is the trader's responsibility, not the Event Cleaners.

### **Trading Hours**

Wednesday Pre Event Set-Up Completed by 6pm  
Thursday to Sunday 8.00 am - 6.00 pm

*Trading hours may only be amended subject to written approval from Yeehah.*

### **Accreditation and Car Passes**

As a tenant, you will be issued with four (4) sets of accreditation and one (1) Inner Paddock vehicle pass for each site booked. Accreditation can be collected from Wednesday pre Event, from the Accreditation Centre, which is located in a Demountable Building at the Main Pedestrian Gate.

### **Insurance**

Yeehah does not accept any liability for any goods or services you sell at the Event and you are required to effect insurance in accordance with State legislation, specifically Public Liability Insurance to a minimum limit of \$10 million for each occurrence. You must produce a Certificate of Currency no later than thirty (30) days pre Event.

### **Circuit Merchandiser Agreement**

A Circuit Merchandiser Agreement will be sent to you on booking of a site. Your booking will not be confirmed until this Agreement has been signed, returned to Yeehah and full payment made for the site(s). This Agreement covers such issues as approved products, conduct and insurance and indemnity issues.

### **Workplace Health and Safety Policy**

Workplace Health and Safety regulations will prevail. Should you require additional information or have any queries in relation to Workplace Health and Safety, please contact the Circuit Manager, Mark Rayner, on 0488 121 000.

### **Security**

We do not provide dedicated security to a particular site, however general precinct security operates. Should you leave valuables on your site, it is then your responsibility to make sure your site is secure. Contact details for the Security Company are provided on the Official Supplier List, which will be forwarded to you with confirmation of your site.

### **Event Logo**

You are not permitted to use the official Event logo without prior written approval from Yeehah.

### **Travel and Accommodation**

The Bathurst Visitors Information Centre produce a list of accommodation providers which can be found on the Event website. Additionally, you may contact the Bathurst Visitors Information Centre on (02) 6332 1444. Camping is also available at the Circuit, in the Paddock Campgrounds. Sites (8m x 8m) can be purchased for \$85 per site – visit [www.challengebathurst.com](http://www.challengebathurst.com) to book online.

### **Access**

✓ No site access is permitted until the Site Manager (Adrian Dalton) has been contacted on 0418 340 616.

- ✓ No access will be permitted from 0600 hours on Thursday without accreditation (wristband & vehicle passes).
- ✓ No access will be permitted if the Circuit Merchandiser Agreement has not been received signed by Yeehah.
- ✓ No access will be permitted if Site Fees have not been paid in full.
- ✓ No access will be permitted unless a satisfactory Certificate of Currency has been submitted to Yeehah.

### **Summary**

Over 420 competitors attended the 2017 Event and we expect an increase in 2018. The site fees offered for this Event are reflective of the limited availability of space in the Inner Paddock.
